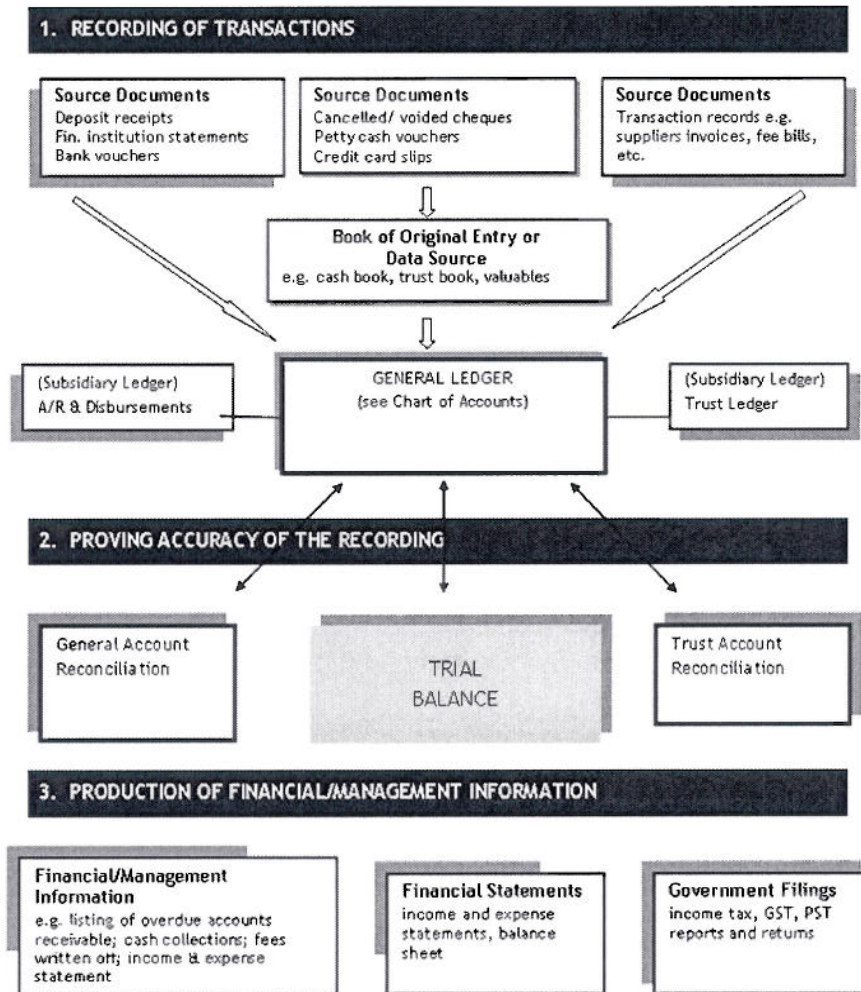


Appendix A: The Accounting Process
